Hello ASC,

I went to US Bank this month to be added to the area bank account. There were still 5 previous trusted servants on the area's bank account. I made sure that the only members remaining on the account are Vice Chair, Literature, Treasurer and Assistant Treasurer. The rep informed me that the login for our online account should remain the same. That rep was incorrect. As I began preparing for area I noticed the login I have shows no account information, so I will need to visit US Bank to regain access to the online banking. I will update area next month with this information. As a result I cannot see any of the information I need to generate the monetary portion of my report giving live numbers. Next month I will have an update giving the balances for the month of March.

I paid the previous literature orders that were overdue. Until this week I was under the impression I could only pay these invoices by phone M-F. I called this past week to pay them and was informed I have other options which will streamline how we pay these bills going forward.

I purchased the hot spot for the ASC/PR zoom meetings as directed. The area's debit card declined when I tried to pay for this, so I am requesting reimbursement in the amount of \$31.01, which was the cost to pay for the initial setup and taxes for the hot spot. I was informed that the plan is \$30 and we can pay a small monthly amount on the hot spot itself, so I estimate the monthly bill to be around \$60 per month. I cannot access the online account for this either so I will be reaching back out to T-Mobile to make sure I can login.

I attended the Winter Winners audit this morning which went well. I received a check for their contribution to ASC in the amount of \$221.74.
